Rural Health Disparities - Despite the many positive attributes and assets associated with working and living in rural communities, many rural American population groups experience significant health disparities. Health disparities are differences in health status when compared to the population overall, often characterized by indicators such as higher incidence of disease and/or disability, higher mortality rates, lower life expectancies, and higher rates of chronic pain. Rural risk factors for health disparities include geographic isolation, lower socioeconomic status, higher rates of health risk behaviors, limited access to healthcare specialists and subspecialists, and limited job opportunities. <https://www.ruralhealthinfo.org/topics/rural-health-disparities>

Communicating About Equity

Talking about Health Equity - Addressing the health issues of today involves eliminating persistent inequities and prioritizing the perspectives of people most affected by a problem. Within public health circles, many use the term health equity to express such beliefs and commitments. But there are good reasons to take care when using this phrase more widely. Different audiences have different levels of comfort and familiarity with the concept. Among the general public, the term equity isn't widely understood. For communicators, this means that if you're using the term, it's vital to pair it with a clear explanation.

It defines public health leadership for health equity as the creation of conditions, especially in the face of uncertainty, to improve health through a population-level and community-centered public health approach.
